Sir,

This is in reply to your above referred letter to the President, Kerala Congress, 67 Kumaranasan Nagar, Kadavanthra P.O., Ernakulam, Kerala. Kerala Congress, a registered party was led by Sri. P.C. Thomas as Chairman (President) till 27.04.2021 when Kerala Congress Party merged with the splinter group of Kerala Congress (M) led by Sri. P.J. Joseph. After merger Sri. P.J. Joseph was elected as Chairman (President) of the unified party while Sri. P.C. Thomas was elected as Working Chairman. On 27.04.21 as per Section 29A (9) of the Representation of People Act 1951 the Election Commission was informed of the adoption of the amended party Constitution and furnished a copy of the same to the Commission. A list of the new Office Bearers was furnished to the Election Commission on 27.04.2021 itself jointly by Sri. P.J. Joseph (Chairman), Sri. P.C. Thomas (Working Chairman) and Sri. Joy Abraham (Secretary General). It was also informed that Sri. Joy Abraham, Secretary General of the party was authorised to communicate with the Election Commission of India. A copy of the said letters is attached herewith.

Regarding the directions in the above referred letter to furnish Contribution Reports and Annual Audited Accounts for the years 2017-18, 2018-19 and 2019-20, we submit the following.

- 1. The Party had actually nil Income and Expenditure during 2017-18, 2018-19, 2019-20. Hence audit reports for the above periods are not being furnished. Since the Party had not received any amount as contribution during the above said periods, contribution reports are not furnished.
- 2. In the election to the House of People in 2019 Sri. P.C. Thomas as a contesting candidate then filed the statement of accounts regarding election expenses to the Election Commission. The Party had not received any contribution or incurred any expenses during the said election.
- 3. During election to the Kerala Legislative Assembly 2021 the party had put up ten candidates. A statement of election expenditure of the Party is attached herewith in the prescribed form. The delay in filing the same may be condoned.
- 4. The Party will file Contribution Reports and Annual Audited Accounts for the years 2020-21 and 2021-22 as early as possible.
